\$20 per Saturday, paid by cash to vendors at the SAS Garage Sale on the Saturday you wish to set up a booth. Only one completed and signed vendor agreement is required to be completed for all Saturdays for that year that vendor may wish to have a booth at the SASSM.

The SASSM runs rain or shine and vendors must come prepared for that. All accoutrement, tents, tables, etc. must be provided by the vendor. No refund will be provided due to weather conditions.
